## Penalty

Persons who contravenes any provision of this by-law is guilty of an offence and is liable upon conviction and at the discretion of the Presiding Justice of the Peace or Judge of the Ontario Court (Provincial Division) or other relevant Justice or Judge or Court, to a fine pursuant to the provisions of the Provincial Offences Act, R.S.O. 1990 Chapter P.33, as amended.

## SALE AND STORAGE OF FIREWORKS FOR SALE

- No person shall sell any type of fireworks, except for the 14 days prior to, and on: the days of New Year's Eve, Victoria Day, Canada Day.
- No person shall sell any type of fireworks to any person under the age of 18 years.
- No person shall sell fireworks from a dwelling.
- No person shall sell fireworks without written approval from the Fire Chief for each year of sale.

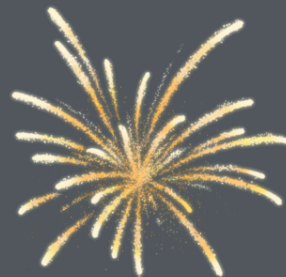
### RETAILERS AND THE SALE OF FIREWORKS:

- Must submit a site layout document indicating fireworks sale area.
- Must ensure that their sales establishment has at least two unobstructed exits, aisles are at least 1.2m wide.
- At least 8m from dispensing stations, retail propane.

**No person shall sell fireworks in a manner which violates these terms**

## SETTING OFF OF CONSUMER FIREWORKS

- No person shall discharge any type of fireworks on any day other than New Year's Eve, Victoria Day, Canada Day. Discharge will be restricted from sunset to 11:00 pm on the designated days.
- No person under the age of 18 years shall set off any type of fireworks within the Town of Aylmer, except under the supervision of an adult or parent.
- No person shall discharge fireworks in a manner that creates, or may create a nuisance or unsafe condition, which could cause danger from fire or risk of accident or injury, or damage to any person, animal, place or thing.
- No person shall discharge any firework under a burn ban.
- No person shall discharge a firework from a motor vehicle.



## HIGH HAZARD FIREWORKS DISPLAY PERMIT

- Every person who wishes to set off any Display Fireworks shall first obtain permission from the Owner of the property and then a Permit signed by the Chief Fire Official.
- Application for high hazard fireworks displays can be obtained from the Aylmer Fire Department and must be received 45 days prior to the venue date. See schedule "A" of By-Law.

## SETTING OFF HIGH HAZARD FIREWORKS

- No person shall discharge or have a display of High Hazard Fireworks without first obtaining a Permit to do so.
- No display when winds are greater than 30 kilometres per hour or when a Fire Ban has been issued.
